To apply for a position:

- You must submit a cover letter and resume.
- Resume must include the following:
  - a list of all significant employment and the primary duties. Employment dates must be specified in month and year format and must state full and/or part-time or total number of hours worked (i.e., work 40+ hours a week, rather than indicating full-time). If part-time, the hours must be annotated to be able to pro-rate the amount of qualified specialized experience.
  - List of employment history must have contact information of previous immediate supervisor. If you do not want us to contact them, you must state that for the respective employer.
  - Education: Must have school name, type of degree received, and subjects studied or degree major. If you attended a trade school, identify the type of certificate, or license received.
