We protect, conserve, and restore shared natural resources which belong to all people. We believe that strong environmental and cultural diversity is integral to the health of all those who live, work, or play in Clackamas County.

To apply for a position:

- You must submit a cover letter and resume.
- Resume must include the following:
 - a list of all significant employment and the primary duties. Employment dates must be specified in month and year format and must state full and/or part-time or total number of hours worked (i.e., work 40+ hours a week, rather than indicating full-time). If part-time, the hours must be annotated to be able to pro-rate the amount of qualified specialized experience.
 - List of employment history must have contact information of previous immediate supervisor. If you do not want us to contact them, you must state that for the respective employer.
 - Education: Must have school name, type of degree received, and subjects studied or degree major.
 If you attended a trade school, identify the type of certificate, or license received.
 - o You must complete the minimum qualifications assessment (Attachment A)
