# SWCD Board Meeting Minutes for May 1, 2013 Special Meeting

### CALL TO ORDER

Chair Oberg called the meeting to order at 8:31 a.m. on Wednesday, May 1, 2013 in the Clackamas County SWCD conference room at 221 Molalla Ave., Suite 102 in Oregon City.

### **PURPOSE**

To approve expenditures and adopt the District Annual Plan of Work for fiscal year 2013-2014.

### **ACTIONS**

**Expenditures**: Staff Lloyd gave an over view of the recurring expenditures including the Voyager Fleet System Invoice for District vehicle fuel, check #4933 for 298.49 This expense was higher than in the past few months due to an increase in field work. No unusual expenses were incurred. <u>Directors Guttridge/Zuber moved/seconded</u> to approve the expenditures as presented. <u>Motion carried unanimously.</u>

Annual Plan of Work: Manager Salzer reviewed the proposed Annual Plan of Work. The due date to Oregon Department of Agriculture (ODA) was April 30, but an extension was granted to allow for board adoption. Director Lee inquired about the scope of work for the Local Management Agency funding. The new process for development of the scope of work allows 25% of the funding to be spent on negotiated tasks and 75% of the funding to be spent on tasks pre-approved tasks for water quality benefit. Directors Guttridge/Zuber moved/seconded to approve the Annual Plan of Work as presented. Motion carried unanimously.

There being no other business announced for this special meeting, Chair Oberg adjourned the meeting at 8:39 a.m.
