☐ Category 1: Manual Site Preparation and Maintenance

Examples of work in this category include priority invasive weed treatments under various site conditions including forests, right of ways, urban and residential sites, and natural area. Activities include invasive weed control, site preparation, and maintenance of native tree and shrub planting ranging in size from less than 1 acre to 1000 acres. The Clackamas SWCD at its sole discretion may choose to have Contractor work hourly. Clackamas SWCD will reimburse Contractor at cost plus 10% for herbicide, surfactants and indicator dye that Contractor uses while performing herbicide application work tasks. Unit prices for work tasks requiring mechanized equipment shall include a qualified equipment operator, all materials like oil and gas, and the necessary safety equipment. Contractor shall be responsible for transportation of crew to and from the site and equipping the crew with tools and safety equipment necessary to complete the work tasks.

Control efforts within the project area will be ongoing and the Contractor must be able to survey for targeted weeds included on the District's Target Species List provided in Attachment A, Exhibit 2. Survey work for most species will be summarized as presence or absence information for each parcel or site. For targeted weeds currently being treated or slated for future treatment patches, patch size, and percent cover will be recorded. Contractor is responsible for collecting GPS coordinates for each nascent patch, sufficient enough to characterize the infestation and allow for relocation of the targeted weed(s).

☐ Category 3: Mechanical Site Preparation and Maintenance

Examples of work in this category include mechanical treatments to manage terrestrial vegetation, including, spraying herbicide with a 10 foot boom or boomless nozzles, and field flailing on sites ranging from 1 to 1000 acres. The District will reimburse Contractor at cost plus 10% for herbicide, surfactants and indicator dye that Contractor uses while performing herbicide application work tasks. Contractor shall provide a lump sum cost to mobilize the equipment to and from the project site at the time the work is requested. See section17 and 18 in the Scope of Work for additional details on equipment cleaning and fueling requirements. Unit prices for work tasks requiring mechanized equipment shall include a qualified equipment operator, all materials like oil and gas, and the necessary safety equipment. Unit prices for work tasks requiring mechanized equipment shall include a qualified equipment operator, all materials like oil and gas, and safety equipment. Contractor shall be responsible for transportation of crew to and from the site and equipping the crew with tools and safety equipment necessary to complete the work tasks.
