These chemicals need to be avoided all together and your job to protect water, wildlife and health needs to be to teach alternatives: media, TV, billboards, warning signs, etc.
- Using safe alternatives as opposed to the chemical cancer causing ones used in weed abatement, insect control, water purity
- · Pollinator friendly environments.
- Preservation of wilderness areas. Conserving land for wild (or "natural") plants and animals is my most pressing concern. Humans are destroying wildlife habitats and natural resources at an unprecedented rate. We must work now to protect what areas we have left!! The Backyard Habitat Program helps (a little) to mitigate some of this loss. As the population increases, people need to be educated and reminded how to interact with local wildlife. Let wildlife live, don't feed them, keep outside lights off or facing down to protect migrating birds, etc. etc. Please help this effort too! People also should learn the harmful effects of chemicals -- pesticides and herbicides. They not only kill the targeted plants and animals, they kill many good insects (bees, for example), and mammals. 9. Please tell us what else you would like Clackamas Soil and Water Conservation District to know:

In County (other)

- There is one important piece of equipment that, if added to your rental program, could do a lot to safeguard water quality and improve soil health. That is a properly sized manure spreader. There are countless tons of manure being collected from barns and feeding areas, and never spread due to the lack of equipment that is too expensive for many small farms. The nutrients and organic matter in these stores are it being made available to the soil, and are instead either being hauled away or leaching into groundwater. We enjoy working with your knowledgeable and helpful staff.
- I bought a house last year in Canemah in Oregon City. I've been removing huge amounts of ivy, blackberry, and clematis vitalba from my property (and replanting with natives; planning to apply for Backyard Habitat within the next year or two), but the neighborhood around me is totally covered with ivy and clematis. Right now I have thousands of clematis seeds on my land that blew in from the surrounding blocks. I would love to see and participate in invasive weed removal projects in my area. Especially since erosion is a serious issue in Canemah, it would be bad news to see all these ivy-choked trees die.
- Please help small farms from being impacted by large agriculture farm practices that hirt their soil quality. Many small farms are trying to attain organic certification, but are constantly dealing with drift from neighboring farm operations that use broadcast spraying methods. This in turn hurts the production quality and yield of food produced by small farms.
- The district does some great work. Focus on showing how a strategy of spending the district funding is benefiting the residents and environment and how that funding is being used wisely to get the most bang for the buck.
- Please have an annual native plant sale!
- Land without water is not much.
- More focusing on invasive weeds that spread.

- I'm sure everyone knows it, but the explosive growth being seen in clackamas county is not great for our rivers and streams. There will be more pollutants entering the water and hurting our fish. We should be doing everything we can to try and prevent these pollutants from entering the water as our cities expand.
- To open public land to clear cutting.
- Rafters have taken their toll on the Clackamas River. The bottom is littered with cans and bottles and who knows what else. I know this because the few times we've rafted, we can see all the cans/bottles beneath us. I also saw someone throwing a bottle into the river. Not only should alcohol be banned from McIver, Barton, and all other parks and put-in places along the river, rafters/boaters/floaters should be prohibited from having cans/bottles with them on the river. Drastic? Maybe. But I can see no other way to stop the ongoing destruction of this beautiful natural resource. It breaks my heart.
- Keep poisons and other toxins out of our water, we don't need to drink Roundup or fluoride for that matter.
- I'm so glad you are there! I haven't worked with you yet because I feel like my property is so terrible I won't know where to start. But I wish i could. If only I could get ahead a little bit. Do you have loaner tools? Tool rental is so expensive for small farmers.
- Appreciate your equipment loan program.
- Strong outreach to master gardeners,OSU, and master recyclers though portland city office
- I have seen the Soil and Water District around and about more at events I attend in the last couple years and it seems like your outreach and social media presence has improved and is more effective. This is a great use of our tax base and I appreciate the efforts to help this county's resources improve and stay robust for all of us.
- The fact that the SWCD can nimbly respond to urgent needs that come up, based on strong existing relationships with private landowners, is very valuable.
- I know very little about the function of CSWCD. More information needed.
- The District has to make stronger legal agreements when it enters into projects with private landowners. There is no point in giving away public money if the District fails to have strong agreements for the projects to continue after they are finished. The District needs to be able to recover money spent if grants are not used as intended.
- I think the SWCD is extorting money from Clackamas County taxpayers. In my opinion, the SWCD has exponentially expanded from the pre-tax base core of 3-4 employees into a bloated taxpayer funded bureaucracy intent on preserving their excess salaries and benefits, engaged in non-essential travel, and
