#### 1 - CALL TO ORDER

A. Call to order – Chair Becker called the Annual Meeting of the Clackamas Soil and Water Conservation District to order at 4:00 p.m. on Tuesday, December 18, 2018.

## 2 - INTRODUCTION

A. Annual Meeting – Chair Becker proclaimed that the annual meeting is required by ORS 568.58o: "Each year after the creation of the first board of directors at a time fixed by resolution of the board and the board, by giving due notice, shall call an annual meeting of the landowners in the district and present an annual report and audit."

- B. Presentation of Annual Report Staff Kilders presented the Fiscal year 2017/2018 annual report. Highlights include a report from General Manager Tom Salzer, Successes in Conservation Planning, WeedWise Highlights, a Financial Summary, and a report on Education and Outreach. Kilders noted that the figures used in the Conservation District Expenditures by fund were unaudited and the report will be updated when we have the final audit numbers.

Associate Director Melethil arrived at 4:10 p.m.

C. Presentation of the Audit – Staff Tucker reported on the draft audit from Richard Winkel, CPA. Tucker noted that this was the first audit using the new accounting software. He also pointed out highlights from the audit including revenue, capital assets, and loan liabilities. According to Tucker, the auditor reported no findings, no issues, and no deficiencies with the Districts internal controls. Winkel will be calling in during the regular meeting to answer any questions that the Board may have. This was a clean audit.
