B. Discussion of employment offer – Directors discussed the salary that they would offer to the candidate. Director Guttridge suggested that Band E/Step 10 was an appropriate level to begin employment. Director Johnson asked to see the list of salaries for employees. Directors discussed different levels, the ability to give the GM an adjustment in salary at the six-month review period and upcoming changes in staffing.

Director Lee joined the meeting at 2:11 p.m.

Directors continued the discuss the compensation package.

C. Approval of employment offer -
