1 – CALL TO ORDER

Call to order – Chair Becker called the meeting to order with a quorum present at 2:30 p.m., March 30, 2021, via "Zoom" initiated from the home office of the Staff Jason Faucera.

Staff Guttridge conducted a rollcall of the budget committee members.

Chair Becker introduced John Keith as a new member of the Budget Committee, and Chris Lapp the General Manager and Budget Officer for the District.

2 – Agenda

Chair Becker reviewed the agenda. No changes were made.

3 – Budget Calendar

Budget Officer Lapp reviewed the budget calendar and noted that no public comment would be taken at this meeting. Lapp noted that he would be presenting the proposed draft budget at this meeting for the committee to review and propose changes. The next budget meeting is scheduled for April 27, 2021 at 2:30. Public comment will be taken at the April meeting, and a Public Hearing will be held on May 18, 2021.

Presiding Officer Squier asked the committee to discuss the budget as presented. Staff answered questions regarding proposed staffing, and scholarships and partner support.

7 – Assignments

Presiding Officer Squier asked if there were any changes that need to be made to the budget as presented. No other variations or assignments were requested. Staff Faucera asked that if Committee members had any questions before the next meeting to please contact General Manager Lapp so that answers will be available at the next meeting.
