#### 1 - CALL TO ORDER and Roll Call

A. Call to order – Presiding Budget Officer Mike Weinberg called the meeting to order with a quorum present at 2:30 p.m. on April 26, 2022, via "Zoom" originating from the Clackamas SWCD office at 22055 S Beavercreek Rd, Beavercreek, Oregon.

Weinberg asked Staff Guttridge to take a roll call and the above Directors and Budget Committee members were in attendance.

### 2 - AGENDA

- **A.** Tasks Presiding Budget Officer Weinberg reviewed the committee's tasks for the meeting:
  - Consider public comment.
  - Discuss/revise the budget as needed.
  - Approve the budget.
  - Approve the property taxes to be levied.

### 3 – BUDGET REVISIONS

Officer Weinberg turned the meeting over to District Manager Lapp and Financial Administrator Tucker.

DM Lapp gave a summary of the ground rules for the meeting and asked Staff Tucker to review the LB-1 Budget form.

Tucker explained a couple of minor wording changes in the budget appendices, and that there had been no changes to the financial portions of the budget. Tucker reviewed the department funds and the special revenue funds. Staff Faucera noted that there was one area on a page which had a ghost number that needed to be removed. Tucker removed the number from the worksheet.

**A.** Officer Weinberg noted that there was no public in attendance on the "Zoom" meeting and no public comment had been submitted in writing for the committee to review.

The motions carried unanimously.

John Borden/Don Guttridge moved/seconded that the Budget Committee of the Clackamas Soil and Water Conservation District approve property taxes for the 2022-23 fiscal year at the rate of \$.05 per \$1,000.00 of assessed value for the permanent rate tax levy. The motions carried unanimously.
